2 APPLICATION

- 2.1 The Applicant herein applies to operate its Drone (details of which are set out in the Schedule) at and around the Atlantic Beach Estate, Melkbosstrand (“**the Estate**”).
- 2.2 The Applicant agrees, warrants and undertakes that, should its application be approved by the ABHOA:
- 2.2.1 it shall only fly the Drone for the Purpose, as recorded in the Schedule;
- 2.2.2 it acknowledges that this application is in respect of the Drone described in the Schedule only and should it wish to make use of any other drones at the Estate, an additional application will be required to be submitted;
- 2.2.3 the Drone will only be flown by the authorised operator(s) set out in the Schedule. Should additional operators need to be approved for flying the Drone, ABHOA will need to consent thereto in writing;
- 2.2.4 the authorised operators are properly trained and possess the adequate level of skill and expertise to fly the Drone and are aware of all rules and regulations applicable to the flying of Drones in the Western Cape and South Africa, including but not limited to the rules issued under the Civil Aviation Act, as amended from time to time;
- 2.2.5 it will ensure that, where applicable, it holds all necessary licenses to operate the Drone (noting that if the Drone footage is to be used for commercial purposes, a license may be required), and it shall furnish the ABHOA with a copy of such licenses simultaneously with submission of this application and updated copies on request from ABHOA;
- 2.2.6 it will ensure that the Drone is not flown within any restricted areas and in full compliance with the rules and regulations issued in respect of the operation of drones, including but not limited to the rules issued under the Civil Aviation Act, as amended from time to time;
- 2.2.7 it acknowledges that the privacy and safety of all owners, members, residents, visitors, workers and contractors at the Estate is of high priority to the ABHOA and any operation of the Drone which infringes on such privacy will not be tolerated by the ABHOA and will be actionable by the ABHOA or the relevant person(s) concerned; and
- 2.2.8 it and its operators will comply in full with the rules issued by the ABHOA from time to time relating to the operation of drones within the Estate in full and acknowledges that it could be subject to the payment of penalties if such rules are not complied with.

3 INDEMNITY

The Applicant hereby indemnifies and holds ABHOA, its board of directors, employees, officers and assigns harmless from and against any loss, damage, claim, costs or expenses incurred by the ABHOA on account of the Applicant operating its Drone or any other drone at and around the Estate, whether in breach of the provisions hereof or not.

4 APPROVAL

- 4.1 In the event that the ABHOA approves the application, such approval shall be effective for a period of 12 months from the date on which such approval is given and the Applicant will be required to re-apply for approval to fly its Drone on an annual basis.
- 4.2 The ABHOA may immediately on written notice withdraw its approval if any provisions set out herein is breached or should it be of the reasonable opinion that the operation of the Drone, or drones in general, at the Estate poses any risk or infringes on the rights of its members in any way whatsoever.
